

**Twin Hickory Elementary PTA General Membership Meeting
May 16, 2013**

The May 16, 2013 PTA General Membership Meeting, held in the THE gymnasium, was called to order by president, Laura DeBusk at 7:00 p.m.

- Laura DeBusk asked for a motion to approve the meeting minutes from April 18, 2013. The minutes were approved.
- Laura DeBusk stated that the April Treasurer's report was posted at the entrance of the gymnasium as well as on the PTA website. Since there were no corrections, the report would be filed for audit.
- Laura DeBusk reported that the PTA Executive Board is recommending to the General Membership that we move to an on-line student directory for the 2013-2014 school year. Our current student directory costs approximately \$900 to produce each year. By moving to an on-line directory, we would save about \$500 per year, as well as be more environmentally friendly. A full printed copy of the directory could be made available to anyone who requested one. The cost for the on-line directory is \$400 and the Executive Board is recommending we make the purchase now so that our Directory Co-Chairs can have the entire summer to familiarize themselves with the program.
- Laura DeBusk asked for a motion to add \$400 to the Student Directory budget to purchase the on-line student directory subscription. Motion was made and second. A voice vote from the General Membership was made and signified by saying aye. No one opposed and the motion carries. This change will be made to the PTA budget in the May Treasurer's report.
- Laura DeBusk reported that the PTA Board has a vacancy in the position of VP of Volunteers. She asked that if there was anyone interested in the position to please let her know by 8pm Friday, May 17th.
- Laura DeBusk reported that the Executive Committee is meeting to slate committee chairs on Tuesday, May 21st. There are still several chair positions that no one has indicated interest in. She asks all PTA members to please consider filling one of these Committee Chair roles on the PTA Board next year. We are still looking for volunteers for the following positions:

 3. We have one person expressing interest in the STEM Lab Chair position, but are looking for a co-chair.
